## (2.) GENERAL RULES FOR EXHIBIT

- **a.**) Entry fees for active and associate members will be \$20.00 for juried shows and for non-juried and sale shows. (v. 9/14) Entry fees are due with the entry form and are non-refundable. (v. 86)
- **b.**) The maximum size of a mini shall be 12" x 14" including the frame. (v. 3/2006)
- **c.**) All work must be original. Original defined: Not a copy of anyone's work. It will not be hung if there is a question.
- **d.**) Work must be suitable and look finished. Stretched canvas pulled to the back is acceptable if edges are painted and in harmony with painting. Staples, tacks, etc., should not show.
- **e.**) Wire stretched tightly between screw eyes must be provided within the top one-third of the painting. Paste hangers are not acceptable.
- f.) Minis having saw-tooth hangers must have a small piece of wire attached to saw-tooth for hanging.
- **g.**) Any member failing to pick up their work from an exhibit shall be fined \$1.00 per day until it is picked up. This money will be added to the Scholarship fund. (v. 5/73)
- h.) No wet painting will be accepted.
- **i.**) Association exhibit boards are to be used exclusively by FBCAA and are not to be rented or loaned to other groups or individuals, including members of the FBCAA who want to use them outside sponsored shows. (v.6/74)
- **j.**) Any show must be brought before membership at a regular meeting or a coffee meeting and approved before it can be sponsored by the FBCAA. At least one (1) show a year will be juried. (v. 5/2016)
- **k.**) Paintings may not be shown more than once except in non-juried revolving shows. If your painting is not accepted in a pre-juried show, you may enter it in another juried show. (v. 7/76)
- **l.**) Paintings may not be taken from shows by artists unless given special permission by exhibit or gallery chairpersons.
- m.) Mechanically reproduced prints will not be accepted in any FBCAA sponsored show. (v. 12/77)
